HOW YOU QUALIFY

Interline rates are available for full-time, part-time, and retired travel advisors.

BOOKING PROCEDURES

1. To see if Interline is available on the sailing, select the 'interline' qualifier in the filters area on your booking tool.
2. Book online using offer 'Interline'
3. Submit verification of employment for confirmed bookings to interline@carnival.com.

VERIFICATION DEADLINE

Verification is due within 72 hours for bookings outside of 2 weeks prior to sailing and 24 hours for bookings inside of 2 weeks prior to sailing.

FORMS OF VERIFICATION ACCEPTED

One of the following forms of verification must be submitted:

- Letter on company letterhead verifying employment from the employee's supervisor, or the company's interline department AND a photocopy of the employee's company identification card. The I.D. must be clearly legible and must show the branded company logo.
- A copy of CLIA, IATA, ARC or TRUE membership or certificate.
- A Travel Business License or Seller of Travel License.

*Note: Interline is also available for select airline and other travel industry personnel. Check GoCCL.com for more details.

ADDITIONAL DETAILS

Qualifying Travel Advisor rates apply to up to (3) staterooms total.

Eligible Family Members

- May book only one stateroom per cruise departure, per family, if the eligible travel advisor is NOT traveling.
- Eligible family members include: husband, wife, mother, or father of the Travel Advisor or dependent children 21 years old and younger.

Retired Travel Advisors

- Retired Travel Advisors may book one stateroom per sailing and must be traveling in this stateroom.
- Retirees do not qualify for the Interline Friends & Family Program and therefore are not eligible to bring any additional cabins under this offer.

All rates are per person, double occupancy, and exclude air transportation. Offer is not combinable with any other promotion or discount. All rates must be booked as cruise only.

TERMS AND CONDITIONS

Cruise rates are in US dollars, per person and based on double occupancy. Offer is capacity controlled and is not combinable with any other discount or promotional offer. Rates may vary by ship, stateroom type and sail date. Changes made to the reservation may result in the assessment of cancellation penalties or service fees. Carnival reserves the right to withdraw and/or change offer at any time without prior notice. Offer is for the cruise fare only and does not include Taxes, Fees and Port Expenses.
